AGED CARE FEES EXPLAINED

Aged Care fees can be a combination of the following table. Please note any government contribution towards the cost of your care, services and accommodation is subject to your individual financial circumstances.

1. BASIC DAILY FEE

Applies to everyone.

Set by the government & indexed at 85% full single standard age pension.

2. ACCOMMODATION FEE

Applies to most people.

Covers the cost of your room.

3. HOTELLING SUPPLEMENT CONTRIBUTION

Applies to some people.

Supplement to Basic Daily Fee.

4. NON-CLINICAL CARE CONTRIBUTION

Applies to some people.

Contributes to costs like bathing, mobility and lifestyle activities.

- 1. **Basic Daily Fee:** an amount that everyone pays and is used to contribute towards your day-to-day living costs and services such as meals, cleaning, electricity, and laundry.
- 2. **Accommodation Fee:** these fees vary by Aged Care Facility and room type. Please find more detail below as well as payment options.
- 3. **Hotelling Supplement Contribution (HSC):** is means-tested with a maximum daily fee capped at \$22.15. Residents who can afford to pay their full accommodation costs will contribute to their day-to-day living costs such as meals, cleaning, laundry, and utilities.
- 4. Non-Clinical Care Contribution (NCCC) is a contribution towards non-clinical care costs such as bathing, mobility assistance and lifestyle activities. It will only apply to residents who can afford to pay the full Hotelling Supplement Contribution, and is means-tested with a daily cap of up to \$105.30. The NCCC will also have a lifetime cap where it will no longer be payable when the resident has been in aged care for more than four years; or the resident has paid \$135,318.69 (indexed) in total NCCC's.



ACCOMMODATION PAYMENT OPTIONS

There are three payment options available to fit your budget and circumstances:

- 1. Refundable Accommodation Deposit (RAD):
 - o A one-off lump sum deposit, 100% guaranteed by the Federal Government.
 - o Retention amounts apply to all lump sum RAD/RAC*'s paid, calculated daily and deducted monthly at the rate of 2% per annum, and capped at a maximum of 5 years.
- 2. Daily Accommodation Payment (DAP):
 - o Non-refundable, rental style, daily accommodation payment.
 - o Indexed twice a year (20 March and 20 September) with the change in the Consumer Price Index (CPI).
- 3. Combination RAD/DAP:
 - o a combination of a RAD and DAP payment.
 - o RAD retention & DAP indexation also apply to combination payments.

ACCOMMODATION FEE

Our **Superior Accommodation** is spacious (17sqm), complemented by traditional yet elegantly understated décor, and feature a shared or private ensuite. All are situated on the ground floor.

Inclusions: king-single automated bed, recliner chair, overbed table, reverse cycle air-conditioning, ceiling fan, wall-mounted TV, armchair for visitors, ample storage, emergency call system.
